

## **Eyebrows/ Lips/ Eyeliners Tattoo Waiver**

WAIVER, RELEASE, AND CONSENT FORM

I am over the age of 18, am not under the influence of drugs or alcohol, am not pregnant or nursing and desire to receive the indicated ombre powder brows procedure. The procedure to be performed has been explained to me. Eyebrows Touch-up is included in the original price ONLY if you come on the second app that we set at your first appointment. With this included-touchup app, you are only allowed to reschedule one time, and you have to notify us 48 hours or 24 hours before your appointment day. Important note, for lips & eyeliner touch-up, the only case we offer free touchup is when you have no result at all (your skin doesn't hold the pigmentation at all). And you must set up an appointment with us after 1 month, counting from the procedure day. Please make sure to read more on the touch-up policy on the next page.
I accept the responsibility for determining the color, shape and position of the brows as agreed during consultation. I fully accept that non-toxic pigments are used during the procedure and that the result achieved may fade over a period of 1-3 years. Even once the color fades, pigment itself may stay in the skin indefinitely.
I have been informed that the highest standards of hygiene are met and that sterile, disposable needles and pigment containers are used for each individual client, procedure and visit.
I understand the result of the procedure can be affected by the following: medication, skin characteristics (dry, oily, sun damaged thick or thin skin type), pH balance of your skin, lifestyle (tanning, sun exposure, exfoliating, daily skincare routines), and aftercare.
Upon completion of the procedure there might be swelling and redness of the skin, which will subside within 1-4 days. In some cases, bruising may occur.
I have been advised that the true color will be seen 1 month after each procedure, and that the pigment may vary according to skin tones, skin type, age, and skin condition. I understand that some skin types accept pigment more readily and no guarantee on exact color can be given.
To my knowledge, I do not have any physical, mental or medical impairment or disability that might affect my well being as a direct or indirect result of my decision to have the procedure done at this time.
I agree to follow all pre and post-procedure instructions as provided and explained to me by LoAnn - LoAnn's brow art studio. Failure to do so may jeopardize my chances for a successful procedure.
I have been informed of the nature, risks, and possible complications and consequences of permanent skin pigmentation. I understand the permanent skin pigmentation procedure carries with it known and unknown complications and consequences associated with this type of cosmetic procedure, including but not limited to: allergic reaction, infection, scarring, inconsistent color, and spreading, fanning or fading of pigments. I understand the actual color of the pigment may be modified slightly, due to the tone and color of my skin. I release the technician from liability if I develop an allergic reaction to the pigment.
I fully understand this is a tattoo process and therefore not an exact science but an art. I understand that every effort will be made to avoid asymmetry but our faces are not symmetrical.
Because pigments used in permanent cosmetic procedures contain inert oxides, a low level magnet may be required if you need to be scanned by an MRI machine. I understand that I must inform the technician.
If I am unhappy with results, I will not slander LoAnn-LoAnn's brow art studio in any online forum including but not limited to: Instagram, Facebook, and Twitter. I will contact LoAnn-LoAnn's brow art studio to allow her to work with me to find a solution.
I hereby consent to, and authorize the use by LoAnn-LoAnn's brow art studio of the specified ombré power brows photographs and/or video; that is, photographs taken before, during and after my ombré power brows procedure. It is understood that these photos may be used on the web site, social media accounts, and in-office for demonstrational and promotional purposes. I understand that I am not entitled to compensation for these photos being used.

## **EYEBROWS TOUCH-UP POLICY**

The Touch-up is about 45-60 days (~1.5-2 months) from the treatment date (touchup may be needed or may not needed, depending on how your skin holding pigment- if you think you already happy with your results then you don't need to come for the touchup)

The touchup will be included if you come on the second app that we set at your first appointment. With this included-touchup app, you are only allowed to reschedule one time, and you have to notify us 48 hours or 24 hours before your appointment day.

lf you have your touchup app, but then you are not showing up for your touchup, or cancel, or reschedule last minute, then you just have to pay an extra \$100 to book for another day - You don't need to tell me your reason because if everyone do the same then it will be too much for me to keep up-so please just follow the rule and it will be better for both sides.

After the second visit- any additional touchup is gonna be \$100 extra between 3-5 months. Price list for touchup:

- \*6-15 months (yearly touchup) is \$200.
- 16 months-2 yrs is \$350.
- \*\*longer than 2 yrs is full price.

You will need to deposit \$50 (non-refundable) to secure your touchup app, also to make sure you come on your appointment day. You are only allowed to reschedule one time, and you have to notify us 48 hours or 24 hours before your appointment day. The touchup policy is applicable to everyone. No exception. *Thank you for your attention*.

## LIPS & EYELINER TOUCH-UP POLICY

We do not offer free touchup for lips & eyeliner, due to normally lips and eyeliner heal perfectly. Also, before performing the procedure, we already went through the consultation session to decide on the thickness, shape, shade (color), together on the appointment day. So later if you want to change the thickness, fill in more color or refresh, then you have to pay the extra. The only case we offer free touchup is when you have no result at all (your skin doesn't hold the pigmentation at all). And you must set up an appointment with us after 1 month, counting from the procedure day. With this touchup app, you are only allowed to reschedule one time within the first 4 months after the procedure was done, and you have to notify us 48 hours or 24 hours before your appointment day. If you wait for longer than 4 months, then you have to pay \$200.

lf you have your refresh touchup app, but then you are not showing up for your touchup, or cancel, o reschedule last minute, then you just have to pay an <a href="mailto:extra \$200">extra \$200</a> to book for another day - You don't need to tell us your reason because if everyone do the same then it will be too much for me to keep up-so please just follow the rule and it will be better for both sides.

Price list for lips or eyeliner refresh touchup:

- The first 2 years or yearly touchup is \$200.
- \*After 2 years is \$400.
- \*After 4 years is full price.

You will need to deposit \$50 (non-refundable) to secure your touchup app, also to make sure you come on your appointment day. You are only allowed to reschedule one time, and you have to notify us 48 hours or 24 hours before your appointment day.

The touchup policy is applicable to everyone. No exception. Thank you for your attention.
